**AUDITOR'S REPORT FOR THE FINANCIAL YEAR STARTED ON
THE 1ST JANUARY 2024 AND ENDED ON THE 31ST DECEMBER 2024 OF

Objective and scope of the review

In accordance with our assignment defined below and confirmed by the Engagement letter of the 3rd of June 2025, we report to you on the audit of the financial statements for the year ended 31st of December 2024. The intended users are the members of the Board of Directors.

We have audited the financial statements of the association Digestive Cancers Europe VZW (DiCE) for the year ended 31st of December 2024, prepared in accordance with the accounting legislation applicable in Belgium, which show a balance sheet total of € 2.510.819,34 and a surplus for the year of € 107.560,35.

The Board of Directors of DiCE ASBL is responsible for the preparation of financial statements that give a true and fair view in accordance with the accounting legislation applicable in Belgium, and for implementing the internal control that the board of directors believes is necessary to draw up financial statements that do not contain any significant anomalies.

In accordance with our Engagement Letter, our responsibility is to express an opinion on these financial statements based on our audit.

We conducted our audit in accordance with the standard relating to the contractual audit of SME's and small (international) not-for-profit associations and foundations and the shared legally reserved tasks in SME's and small (international) not-for-profit associations and foundations.

This standard requires that we plan and perform the audit to ensure that the financial statements are free from material misstatement. We have complied with all deontological requirements relevant to the contractual audit of the financial statements in Belgium, including those related to independence as provided for in the aforementioned standard.
